The impact of the economic recovery could be felt as Caroline County businesses began to invest in new equipment, market expansion, product development, and the hiring of new employees. You will find many specific examples of these activities throughout this report.

This was my first year as Director of Economic Development with Caroline Economic Development Corporation, so FY2014 was largely focused on taking stock of the county's current business climate. I met with all of the county's largest employers, as well as many of its small business owners. The information gathered directly from these businesses has prepared us to create and implement a five-year strategic plan for economic development, which will be completed in the first half of FY2015.

Although this past year was mainly focused on assessment, there were a number of important initiatives that were implemented. The CEDC launched a new website that provides extensive information about the resources and incentives available to help businesses, as well as listings of available commercial properties. We also strengthened our partnership with Caroline County Public Schools and launched the Advanced Manufacturing Professionals program, which connects high school students with local manufacturers.

IN MEMORIAM Remembering Bill Cooper



On August 5, 2014, the CEDC lost one of its long-time board members and greatest supporters, Mr. William "Bill" Cooper. Mr. Cooper had served on the CEDC Board of Directors for over ten years. He also supported regional economic development efforts by serving on the board of the Mid-Shore Regional Council.

Mr. Cooper also served the community of Caroline County in numerous other ways. He was a volunteer firefighter for 55 years, 48 of which were with the Hillsboro-Queen Anne's Volunteer Fire Company. He was a driving force behind the Length of Service Award Program, which provides a pension for longtime volunteer firefighters.

Mr. Cooper was also an active member of the Hillsboro Town Council, the 4-H Board of Directors, and the Route 404 citizen advocate C-TEAM. He was selected as the first recipient of the Caroline County Distinguished Service Award just before his death.

Above all else, Mr. Cooper was a true gentleman and a genuinely kind man. He led by example and set a high standard for all of us. He will be greatly missed.

Business Retention & Expansion

BUSINESS RETENTION VISITS

The CEDC met with more than 50 Caroline County businesses throughout FY2014. These retention visits are an important opportunity to ensure that businesses have the resources they need to thrive in Caroline County. The following list is a small sampling of activities the CEDC engaged in to help businesses following retention visits:

- Site selection for expansion and relocation projects
- Assistance complying with new environmental regulations
- Finding access to capital for expansion projects
- Assistance with applications for tax credit programs
- Connecting businesses to broadband internet service
- Identifying resources and funding for energy efficiency upgrades
- Assistance acquiring permits for new equipment
- Assistance with international market research and export assistance
- Providing recruiting leads for key personnel positions

CAROLINE COUNTY SMALL BUSINESS LOAN PROGRAM

Caroline County's Small Business Loan Program has been tremendously successful in helping new businesses launch and grow. As one of the few counties on the Eastern Shore with a small business loan program, Caroline County offers a distinct advantage to entrepreneurs. Small businesses that have access to capital during their launch are far more likely to survive and thrive than those that don't.

In FY2014, there was one new small business loan issued to Knaggs Guitars of Greensboro. The new loan was consolidated with an existing Caroline County Small Business Loan balance from when the company first launched in 2009. The additional funds were used by Knaggs Guitars to invest in new equipment and inventory, which has allowed the company to launch new products and enter new markets.

In addition, there were two small business loans that were restructured in FY2014: Nice Farms Creamery and Blades Orchard. The restructured loans ensure that both businesses will have adequate capital to keep pace with their rapid growth.

Knaggs Guitars, Nice Farms Creamery, and Blades Orchard are great success stories for the Caroline County Small Business Loan Program. Each company has demonstrated that small loans can make a big difference in how quickly new businesses grow and expand.

CEDC CONNECTS CAROLINE MANUFACTURERS WITH INTERNATIONAL BUSINESS RESOURCES

In December, the CEDC arranged meetings between four Caroline manufacturers and the Maryland Department of Business & Economic Development (DBED). A representative from DBED's international team met with Tanglewood Conservatories, Combined Technology Solutions, Valpac, and Yale Sportswear at their facilities. Each of these businesses learned about the resources DBED offers to help Maryland businesses grow their exports. These resources include a travel reimbursement grant and customized, market-specific research services. The CEDC helps businesses complete their applications for these grants and coordinates submission to DBED.

COMPANY HIGHLIGHTS



Choptank Transport Receives One Maryland Tax Credit Approval: One of Caroline County's fastest growing companies, Choptank Transport, received final approval for a significant state income tax credit following the completion of its recent office expansion. The One Maryland tax credit will enable the company to recoup the full cost of its project investment over the next several years.

To support Choptank Transport's continued growth, the CEDC is working to ensure that the county's broadband infrastructure is sufficient to meet their needs. The CEDC is also working with Caroline County Public Schools and Chesapeake College to develop customer service training and internship programs that prepare students to work for Choptank Transport and the county's other logistics companies.



Tri-Gas & Oil Expands Service Offerings: Over the past year, Tri-Gas & Oil has significantly expanded the services it offers to customers throughout the Delmarva region. Through a combination of organic growth and acquisitions, TG&O now offers a full range of HVAC services, including geothermal heating and cooling.

The CEDC has met with TG&O to review the One Maryland Tax Credit and other incentive programs that will support their continued growth.

ACTIVE BUSINESS RETENTION & EXPANSION PROJECTS

As of June 30, 2014, the CEDC was managing three significant, active retention projects. These projects are related to broadband internet expansion, improved rail access in the Federalsburg area, and a possible expansion project for a manufacturer that is launching a new product line. Because these projects are in the early stages, the specific details have not yet been announced publicly.

Each of these projects will have a significant and positive impact on Caroline County. The infrastructure projects were initiated to retain and grow two specific Caroline County businesses, but they will also benefit other existing companies and make the county more attractive to new businesses. The expansion project will increase the county's tax base and add new manufacturing jobs.

Business Attraction

MID-SHORE TECHNOLOGY PARK IN RIDGELY

The CEDC has secured a verbal commitment from an Information Technology firm that will be the first to build in the Mid-Shore Technology Park located in Ridgely. Initial plans call for a 10,000 ft² building that will employ approximately 20 people. The company is growing rapidly and expects to employ over 50 people at the Ridgely site within three to five years.

The project is expected to get underway and be officially announced in FY2015. The CEDC will be assisting the business with its One Maryland Tax Credit application, all necessary permits, and acquisition of the site.

As of June 30, 2014, there were two additional businesses that have expressed strong interest in the Tech Park. The CEDC will be working with both businesses to identify financing, incentives, and technical assistance as their projects move forward.

OTHER ACTIVE ATTRACTION PROJECTS

As of June 30, 2014, the CEDC was managing three additional significant attraction projects. These leads include a large hydroponic greenhouse operation, a technology research lab, and an automotive parts distributor. The CEDC has performed a variety of services for these companies:

- Site selection and evaluation
- Identification of eligible state incentives
- Preliminary meetings with Planning & Codes, the Health Department, and other relevant agencies
- Connection with financial institutions and project funding sources
- Introductions to similar or related businesses already operating in Caroline County

NEW BUSINESS HIGHLIGHTS



Max's Business Furniture, LLC: Rockville-based Max's Business Furniture expanded to include a new warehouse and refurbishment center in the Denton Industrial Park. The new location will help the company expand its services to cover more of the Maryland and Delaware markets. Max's employs eight people at its Denton location.

The CEDC has connected Max's with resources for energy efficiency upgrades at its new warehouse. The CEDC is also working with the Town of Denton to review possible changes to the industrial park covenants that would allow Max's to offer a limited retail operation at its location.



R&M Performance: R&M Performance opened a satellite location on Rt. 404 in Denton for its auto restoration business. The company also has a shop located in Cambridge. R&M specializes in classic Mustang, Camaro, and Chevelle restoration, and they have a stellar reputation for the quality of their work.

The owners of R&M Performance are exploring the possibility of adding a Hard To Handle Sub Shop at their new location. The CEDC is helping them navigate Health Department requirements and will also be assisting with marketing of the new business.

Business Startups

GREAT THINGS ARE BREWING IN CAROLINE COUNTY!

Caroline County will soon be home to two microbreweries.



Resonator Brewing will be opening its brewery on Bell Street in Ridgely. Resonator has already built a strong following through its appearances at beer festivals and competitions throughout the Mid- Atlantic region. Resonator Brewing plans to open its doors in Fall 2014.



Federalsburg Brewing Co. has acquired a former bank building located on Main Street in Federalsburg. Renovations are underway to convert the building to a microbrewery and coffee house. The menu will feature locally sourced foods and a variety of creative beers. Federalsburg Brewing Co. expects to open its doors in Spring 2015.

The CEDC will be working with both breweries to secure necessary permits, obtain financing, and provide marketing assistance. The CEDC has also connected both businesses with resources for business plan development.

OTHER ACTIVE STARTUP PROJECTS

Although there were relatively few new businesses launched in Caroline County in FY2014, startup activity increased significantly in the second half of the year. This indicates that FY2015 will likely be much stronger in terms of new businesses that are launched in the county. As of June 30, 2014, the CEDC is actively managing seven small business startup projects. These startups cover a range of products and services, including automotive detailing, a coffee shop, and a bakery, among others.

Workforce Development

ADVANCED MANUFACTURING PROFESSIONALS (AMP)

The CEDC has partnered with Caroline County Public Schools to launch the Advanced Manufacturing Professionals (AMP) program. The AMP program exposes top pre-engineering and technical students from both county high schools to local manufacturers. The program is integrated with the schools' STEM curriculum (science, technology, engineering, and mathematics) and provides real-life examples of STEM careers.

In March, the AMP group toured M&M Refrigeration, Tanglewood Conservatories, and Combined Technology Solutions. Students learned about various manufacturing careers and were able to speak directly with several employees from each company.

The ultimate goal of the AMP program is to retain top talent by making students aware of the strong career opportunities available with Caroline County's manufacturers. As the program grows, students will be connected with internship opportunities for direct, hands-on learning experiences.

UPPER SHORE WORKFORCE INVESTMENT BOARD

Director of Economic Development Angela Visintainer joined the Upper Shore Workforce Investment Board (WIB) as the representative for Caroline County in September. The WIB provides job training and a variety of other workforce services to job seekers and employers. As a board member, Visintainer will help ensure that the WIB's job training programs align with the needs of Caroline County employers.

In April, the CEDC supported the WIB's application for an Employment Advancement Right Now (EARN) grant, which would provide employee training funds directly to Eastern Shore manufacturers. The grant application was not ultimately successful, but the WIB will have another opportunity to apply in FY2015 if the State of Maryland continues the EARN program. The CEDC will continue to support efforts to provide manufacturers with training resources.

Marketing

Marketing was one of the major initiatives for the CEDC in FY2014. Economic Development launched a new logo, website, social media platform, and print collateral to position Caroline County as a great place to do business.






FY2014 Budget Summary

FY2014 ECONOMIC DEVELOPMENT BUDGET SUMMARY

Cost reduction and efficiency were top priorities for CEDC staff in FY2014. Payroll expenses were reduced significantly by eliminating a part-time administrative assistant position. Several other expense categories also saw significant reductions. In total, the CEDC reduced expenses by over \$30,000 without any reduction in services and while launching a new website and several other new initiatives.

Economic Development ended the year with cash reserves to carry forward into FY2015. The reserves will be put toward funding for the five-year strategic plan that will be developed in FY2015.

Looking forward to FY2015

The CEDC has exciting plans for FY2015. These are a few of the highlights:



FIVE-YEAR STRATEGIC PLAN FOR ECONOMIC DEVELOPMENT

The CEDC is in the process of creating a five-year strategic plan that will guide its economic development efforts. The plan will focus on business retention and attraction, entrepreneurship, workforce development, infrastructure, and local policy. The CEDC has been awarded a grant from the Maryland Department of Business & Economic Development that will cover 50% of the plan expenses. The plan will be completed and presented to the public in late 2014.



EASTERN SHORE VALUE-ADDED AGRICULTURE PROJECT

The CEDC has been awarded a Maryland Agricultural Education & Rural Development Assistance Fund (MAERDAF) grant for a project to attract new value-added agriculture businesses to the Eastern Shore. The project will also help existing local farmers who are interested in diversifying a portion of their operations to include a value-added component.

Value-added agriculture refers to the process of increasing the economic value of a commodity through a production process and/or product branding. It complements traditional agriculture by providing diversification and new revenue streams.



EXPANDED PARTNERSHIPS WITH CAROLINE COUNTY PUBLIC SCHOOLS AND CHESAPEAKE COLLEGE

The CEDC will be working closely with its education partners to prepare students to meet employers' needs, particularly in the areas of skilled manufacturing and customer service.



LAUNCH OF MARYLAND'S EASTERN SHORE ECONOMIC DEVELOPMENT MAGAZINE

Caroline County will be featured in this regional project to attract new businesses to the Eastern Shore. The magazine and corresponding web portal on BusinessClimate.com will both launch in FY2015. The web portal will reach a global audience of site selectors and business executives. The magazine will be distributed at conferences and tradeshows, and will also be used to follow up on new business leads.
